Session Description including objectives and expected outcomes (500 words maximum):

Session Background

The session takes stock of the data and reflections on groundwater developed in the UN World Water Development Report "Making the invisible visible (2022)", at the 9th WWForum (Dakar 2022), the IAH Conference on "Groundwater, Key to the Sustainable Development Goals" (Paris 2022 Home (gw-sdg2022.fr)), and lastly the UN-Water Joint Message and Call for Action on Groundwater (UN-WATER Summit on Groundwater, UNESCO 2022).

The largest component of the freshwater resources is contained underground in aquifer systems. Groundwater provides drinking water for half the world's population and supports global food security. It also supports ecosystems worldwide through extensive interconnections with soil, land and surface water systems. However, groundwater governance is still poorly developed or non-existent. Due to its invisible nature, sustainable management and sound governance of groundwater have been under-prioritised. Yet sound governance ensures the sustainability of groundwater for the benefit of people and ecosystems. In addition, there are over 450 transboundary aquifers around the world, the governance of which needs to be strengthened to promote international cooperation.

As emphasised in the recommendations of recent international events, we need to integrate groundwater into IPCC studies and better understand its role in climate change and adaptation.



Session Objectives

This session will look into the challenges and solutions towards better groundwater governance, focusing on best-practice examples from national and subnational governments, civil society, businesses and academia from across the world. It will strive to provide a platform for voices with a strong stake in good groundwater governance. The session will then contribute to promoting better governance of groundwater in order to move towards sustainable groundwater management. The interventions will contribute to highlighting that, even if groundwater is invisible, it plays a key role in achieving many SDG targets by 2030.
