Session Description including objectives and expected outcomes (500 words maximum):

Indigenous Peoples and local communities have sustained systems of freshwater governance, management and complex knowledge systems over many generations. From equatorial rainforests, to deserts, small islands and the High Arctic, Indigenous Peoples have been able to adapt their systems of governance and management to very different ecosystem contexts. The aim of the session is to learn about different practical examples of Indigenous and local water management and governance, and to consider how this can be supported by science and policy making. The aim is a paradigm shift in working with different knowledge systems in understanding and making decisions on water.

Drawing on a range of case studies, Indigenous peoples and local communities share their experiences of knowing and protecting freshwater, according to their cultures, values and knowledge systems. This perspective is complemented by contributions from the UN system and governments that are finding new ways for multiple evidence-based approaches to environmental decision making, and ways in which formal science and Indigenous and Local Knowledge can enter into respectful dialogue and generate new information, approaches and norms.

Whereas there has been substantial knowledge in United Nations and different national context in building relationships between Indigenous Peoples, scientists and policy makers on biodiversity and climate change, freshwater knowledge and systems of governance and management have received less attention, and the space is sometimes highly contested. In the preparations for the Mid-Term Review of the UN Water Action Decade, Indigenous Peoples describe water as being at the centre of their cultures, food systems, sustainability and understanding of the world. At the same time, water is one of the most difficult policy spaces, with numerous challenges of privatization, contamination, rapid climate change impacts, and over extraction.

The UN Water Conference of 2023 provided one of the world's largest ever forums to discuss rights-holders relationship with water, water policy, management and governance. Indigenous Peoples, in cooperation with national governments and the United Nations System placed emphasis on the need for multiple knowledge systems, human rights and interculturality as way to ensure water for future generations.
