Session Description including objectives and expected outcomes (500 words maximum):

The global discourse on the importance of responsible business practices has been rapidly growing in the last ten years due to investor interest, consumer pressure and regulatory demands. More and more businesses have been adopting human rights policies and engaging in Human Rights Due Diligence (HRDD) practice, as outlined by the UN Guiding Principles on Business and Human Rights (UNGPs). HRDD requires businesses to identify, prevent and mitigate adverse impacts on human rights including the newly recognized right to a clean, healthy and sustainable environment.

This session on, "Access to Clean Water and the Business and Human Rights in Asia" offers an avenue for government, businesses, and civil societies to exchange views on practices and share experiences in solving water challenges with a focus on water pollution in river basins.

The session is a collaboration between United Nations Development Programme (UNDP) and the Indonesian Coordinating Ministry of Maritime Affairs and Investment. The session will introduce the UNGPs and briefly explore its relevance to solving environmental challenges. The UNGPs are widely considered to be the world's most authoritative, normative framework guiding responsible business practices today. Still, its practical application to water, air and soil pollution is only now being explored.

After introducing the UNGPs, the session will pivot to a case study of the Citarum River in West Java, Indonesia, renowned as one of the world's ten most polluted rivers. Industrial waste, comprising plastics, sewage, harmful chemicals and heavy metals has severely contaminated the river, undermining water security, and affecting the prosperity of communities along its banks and beyond. The session will also highlight how key stakeholders including government, business and civil society worked together in promote the right to clean and safe drinking water within the Citarum River Basin.



Lastly, the toolkit on human rights and environmental due diligence (HREDD) will be introduced in the session as the framework for business to self-assess their risks to human rights with a focus on water pollution.

The session aims to achieve two main objectives: (1) drive business's attention to the interconnections between business, human rights and the environment, and (2) introduce possible solutions linked to the implementation of the UNGPs.

Targeted audience: governments, civil societies, private enterprises, and state-owned businesses.
