Session Description including objectives and expected outcomes (500 words maximum):

The **purpose** of this session is to elucidate how global water-related processes, initiatives and upcoming events such as the UN 2026 Water Conference connect to recently adopted United Nations Environment Assembly (UNEA) water-related resolutions to help member states enhance their water resource management in alignment with SDG6.

The following **focus areas** are suggested to achieve this purpose:

- Overview of global water-related events and initiatives including the forthcoming UN Water Conference in 2026, the One Water Summit, Freshwater Challenge, UN System-Wide Strategy on Water and Sanitation.
- Introduction to recently adopted UNEA6 Resolution 13 on "Effective and inclusive solutions for strengthening water policies to achieve sustainable development in the context of climate change, biodiversity loss and pollution" and other water-related UNEA resolutions and their implementation;
- Sharing an update on the preliminary findings on forth coming progress report on SDG 6 indicators for which UNEP is a custodian (6.3.2, 6.6.1 and 6.5.1);
- Discussion on issues such as the importance of governance, integrated water resources management, stakeholder engagement (especially in a transboundary context), and circular economy are vital to addressing the water crisis.
- Promotion of actions addressing water resilience and security, particularly within the Water-Energy-Food-Ecosystems and Health (WEFE+H) nexus and in the context of water-related national strategies and plans;

Expected Outcomes:

 Increased awareness on the issues to be addressed to achieve global water resilience including why global action on this is so urgently needed and how UNEP, through its partnerships, can help overcome some of the current water-related challenges the world is facing.



- Increased awareness of global programmes, platforms and initiatives and need for alignment across multilateral agreements and frameworks; a whole-of-government approach and a whole-of-society contribution including active private sector engagement.
- Enhanced engagement from diverse sectors, including energy, agriculture, and finance, in addressing water-related challenges in the context of the WEFE+H nexus.
- Advocacy for effective and inclusive solutions for strengthening water policies to achieve sustainable development in the context of climate change, biodiversity loss and pollution, linking to recent UNEA resolutions and other pertinent initiatives.

The session targets a broad audience, particularly member states and stakeholders involved in freshwater conservation, management, monitoring also from non-governmental, private sectors and youth to foster intergenerational dialogue and collaboration.

The session will be held in a format with three high level keynote speeches, followed by a panel discussion.
