### **HLP Session Description including objectives and expected outcomes:**

Water resources are inextricably linked to the ecosystems which sustain the water cycle. In an era marked by rapid climate change, accelerating losses of biodiversity and degradation of lands and waters, the very ecosystems we depend on are under great strain, impacted by the very actions of water users themselves. There will be no water security without ecological security, and no ecological security without water security, thus no socio-economic security either.

This is a critical moment for the water sector to find common cause and shared narrative with conservation and climate actors to leverage their momentum and to inform their actions. Adopting integrated water resources management using a landscape approach, preserving intact ecosystems, restoring watersheds and their freshwater ecosystems, and optimizing green infrastructure investments (i.e., nature-based solutions) can be cost-effective means to advancing water security goals. The business case has become very clear at the river basin level, such as the Yangtze and Yellow River basins in the People's Republic of China, and cities as diverse as Sao Paolo, Nairobi, Quito and Cape Town. Nature-based solutions bring tangible benefits to water security, biodiversity, climate mitigation and adaptation, as well as rural livelihoods. Further momentum to be built from the The Water and Nature Declaration, an initative launched to strength the links between water practitioners and the nature community and foster a new level of collaboration. The question is not if nature and water communities should align, but how to scale this alliance as quickly as possible.



**Objective**: This HLP will examine success from both top-down and ground-up actions, revealing common challenges and breakthrough solutions to mainstreaming nature-based solutions in the water sector.

This HLP will showcase how government leadership and ministerial decision makers have leveraged efforts that meet national goals under the UN Rio Conventions on climate, biodiversity loss, and land degradation to also meet water security goals of UN SDGs. Panelists will include government Ministers, high-level officials, as well as the representatives at the intersection UN processes. Regional development banks, such as the Asian Development Bank, will be invited to describe how they are financing countries climate, biodiversity, and ecosystem restoration plans and where the intersection to water financing lies.

Additionally, panelists that work at the intersection of water supply, such as river basin organizations and water utility managers, will explore the how they have succeeded in creating the business cases for investment in nature, and have established long-term funding flows from public funding and/or rate payers. Major case studies from communities such as PRC, Cape Town and Sao Paolo are already showing the way. Regional alliances between nature and water leaders are now being built, such as the Africa Source Water Protection Alliance, supporting replication at scale.

#### **Desired Outcomes:**

- High-level panelists will discuss current commitments and upcoming initiatives along with plans of implementation and scaling progress. To include:
  - Natural Capital Fund and Nature Finance Initiative
  - Nature for Water Facility and Ground Outcomes Fund
  - Call for enabling policy and lending for NBS for water (and tease of findings of NBS for water enabling conditions paper)
  - o Call to join the Freshwater Challenge ahead of One Water Summit in New York
- Participants will have an increased understanding on how natural ecosystems support a
  healthy, functioning water cycle critical to providing water security and the business case for
  investments in nature-based solutions.
- Participants will have an increased understanding of solutions already being used to overcome common challenges through the exploration of at-scale watershed investment programs across the world.
- Through validation of NBS by knowledgeable, passionate high-level speakers, participants will take action and build alliances with the biodiversity and climate sectors, supported with new resources to support investment in nature as a fundamental asset for greater water security.
