This session will present the Handbook for the Local Implementation of the OECD Principles on Water Governance developed by the OECD Water Governance Initiative (WGI). The WGI co-developed the OECD Principles on Water Governance, which provide the 12 "must do's" for governments to design and implement effective, efficient, and inclusive water policies in a shared responsibility across levels of government and stakeholders. The Handbook for the Local Implementation of the OECD Principles on Water Governance aims to further drive the implementation of the Principles at subnational level (e.g. municipal, regional and basin) by showing water governance practices and highlighting lessons learned for both national and subnational governments. This session will gather representatives from national and subnational government, NGOs, academia and businesses to present the key challenges and lessons learned from the Handbook.
