Session Description (300 words):

The three sessions convened under topic 6B 'innovative organisational approaches' include a diverse array of organisations, case studies, and framings of 'innovation' and what it means for SDG6 and beyond. The intention of the 6B Synthesis Session is to formalise these learnings and collective ambitions into a set of recommendations and commitments, that will enable participating organisations to advance progress towards innovative approaches beyond the Water Forum.

The purpose of this session is to build on commitments made at the UN Water Conference in 2023, announce new collective commitments/recommendations relating to organisational innovation, and assess where progress is still needed to bridge the gap between current progress/approaches and these commitments.

The session will include representatives from the Ministry of Senegal, Global Commission on the Economics of Water, and others across academia, NGOs, and the private sector. Following two keynote speeches, contributors will summarise the learnings from across the 6B sessions and reflect on the practicalities and barriers for implementation, and how to enhance collaboration to cement collective goals.

Summary of sessions under Topic 6B:

6B1: Framing legacy and innovative approaches to understanding and implementing organisational change.

- Through quick-fire presentations and roundtables, this session sets out a conceptual framing of
 organisational innovation, and illustrates the concept through case studies (covering legal cases,
 public authorities, private utilities, peer mentorship, irrigation, finance, and links between expert
 knowledge). A set of policy recommendations from the interdisciplinary journal Blue Papers is used to
 frame the roundtable discussions.
- 6B2: New interventions and integrative approaches for solving complex challenges.
 - This two-part session builds on 6B1 by illustrating further examples of innovation in practice. Presentations included in the first part cover innovation in communications & advocacy, citizen science, and collaboration; whilst the second part of the session focuses on deploying innovation and technology across the utilities sector. This will include an official announcement of the Africa testbed network for utilities.

6B3: Transformative change for the future Water-Smart Society: Linking science, policy and action



• The third 6B session builds on the examples of organisational innovation in 6B1 & 6B2 to concretise good practices and methodologies that create new pathways for water-smart futures. This three-part session will include 1) practices from around the world on how science-policy-action interlinkages can drive progress towards SDG6 (including modelling, living labs, hackathons, mentoring, gamification); 2) roundtables diving into these methodological approaches and how they may be applied in different contexts; and 3) recommendations for policy and decision-makers.

Key messages (2 maximum)

- 1. Participating organisations from topic 6B and beyond are committed to advancing progress towards water security through innovative approaches.
- 2. Writing, sharing, and embedding collective commitments is a key avenue through which organisations can a) ensure meaningful outcomes from international conferences such as the World Water Forum (particularly where commitments build on prior work) and b) build momentum and ambition for implementing innovation.

Concrete outcomes (2 maximum)

- 1. Shared understanding of how to advance and implement the recommendations and commitments from across Topic 6B.
- 2. Reiteration and further promotion of the concrete outcomes & collaboration opportunities presented in the three main 6B sessions.
