Session Description including objectives and expected outcomes (500 words maximum):

Nature is the fundamental asset that underlies the water cycle and therefore all water security. Naturebased solutions, including the protection of ecosystems, restoration of habitat and improved management practices, offer proven pathways to improve water security while also helping combat climate change, reduce biodiversity loss, and improve livelihoods. The question is now not if nature-based solutions work, but how to mainstream them in the water sector.

Common challenges include:

- Policy barriers
- Lack of adequate knowledge both traditional and scientific to design an investment portfolio
- Lack of institutional alignment and governance,
- Poorly defined funding models
- Inadequate stakeholder engagement
- Poor implementation capacity, and
- Lack of evaluation measures.

All of these challenges have solutions that are already being used successfully!

The session will:

- Explore successful watershed investment programs using nature-based solutions
- Provide clear evidence and guidance on how investments in nature can be structured to address the critical interlinked crisis of water security, biodiversity loss and climate change.
- Share methods for developing a scientifically based and socially inclusive plan, far-reaching policy reform that catalyze investments in nature, and evidence of results.
- Explore successful examples of governance, funding, and collective action.

The audience will learn directly from **utilities, regulators, investors, NGOs, research institution and the private sector** on their experiences.

They will return with tangible resources to help them incorporate nature-based solutions in their work.
