HLP Session Description including objectives and expected outcomes:

INTRODUCTION

Over the last five decades, the World Meteorological Organization (WMO) reports an average of one weather, climate, or water hazard-related disaster occurring daily. This figure has surged fivefold, reaching 11,778 incidents between 1970 and 2021. Governments and industries globally are mobilising with a spectrum of objectives, pledges, and tactics in the pursuit of carbon neutrality and an eco-friendly transition. However, they frequently overlook the significance of water as a pivotal component in decarbonisation strategies and pathways to achievement. While recognition of heightened business risks associated with water due to climate change has expanded, and the imperative of water security has garnered attention, this issue often finds itself competing for recognition and resources against other priorities in sustainable development agendas.

Yet the scale of the challenge is huge. Flood risk is growing at an alarming rate across the world, posing increasingly complex challenges to socioeconomic systems, infrastructure, and the environment. According to Marsh McLennan estimates, 18% of the global population is currently threatened by flooding, and even limiting global warming to 2 °C would cause this percentage to double. As we confront the imperative task of future-proofing infrastructure, encompassing the integration of nature-based solutions, it becomes evident that conventional funding mechanisms are insufficient.



The scale of this challenge requires a paradigm shift, demanding us to mobilise novel sources of funding and de-risking approaches to create investor confidence in resilience-building endeavours, particularly in the domain of water infrastructure. Embracing nature-based solutions and resilient infrastructure presents a promising avenue, but it demands innovative financing approaches to unlock their full potential. By derisking investment strategies and fostering collaborative partnerships, we can cultivate an environment where investors are incentivised to engage in the development of resilient water infrastructure, thus fortifying our collective resilience against future environmental uncertainties.

Blended finance is a financial structuring approach that combines different forms of capital to support a common objective, especially in complex investments that have the potential to build resilience in communities and deliver on sustainable development goals. It typically involves the use of public or philanthropic funds to attract private capital, especially for projects that may be perceived as too risky or not immediately profitable. It can be used to address funding gaps, reduce investment risks, and stimulate economic growth and innovation.
