Session Description including objectives and expected outcomes (500 words maximum):

The water sector is facing many other cascading challenges that call for the evolution of legal and governance frameworks at different yet integrated scales, such as:

- 1. enhancing the adaptability of regulatory water allocation instruments, also in response to climate variability;
- 2. balancing efficiency and equity in the allocation of water in the face of increasing competition;
- 3. reconciling the environment-support and the development-support function of water (in which the "rights of rivers" is one innovative and forward-looking response); and
- 4. bridging the land/water divide in law and in its administration
- 5. dealing with the ongoing challenges of corruption and integrity failures.

Objectives: Session participants will (i) address the range and complexity of contemporary legal/institutional issues of water governance, (ii) learn about innovative legal, institutional and policy pathways from around the world to address four key challenges at local, regional and global levels and (iii) discuss elements for a responsible governance of water resources to guide and enhance the implementation of legal, institutional and policy responses to these challenges.

Active engagement of the audience is ensured through an interactive format through working groups.

Outcomes: The session will identify elements for a responsible governance of water resources particularly regarding climate resilient water allocation, realization of the human right to water and



sanitation, Safeguarding water quality for human and ecosystem health, as well as governance of water tenure.

The results will be brought to the attention of policymakers, lawmakers and other stakeholders gathered in Bali through the reporting lines of the thematic process. Furthermore, the results of the deliberations of the session will feed into the Global Dialogue on Water Tenure facilitated by FAO and partners.
